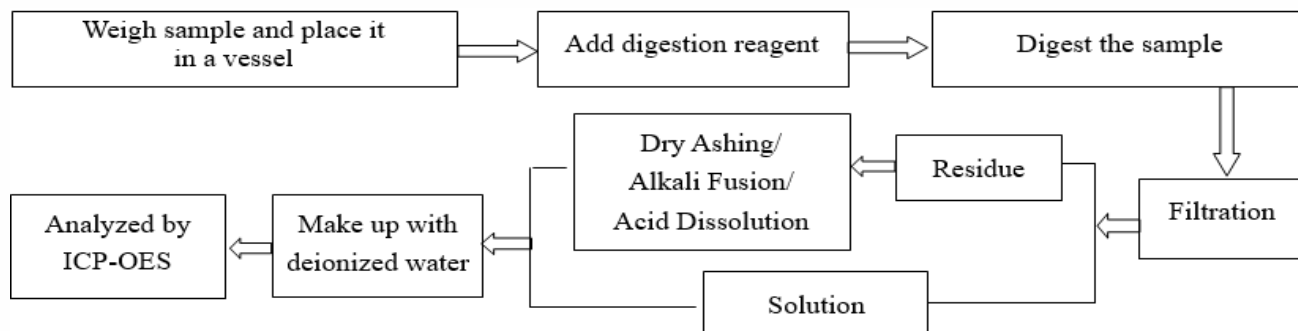

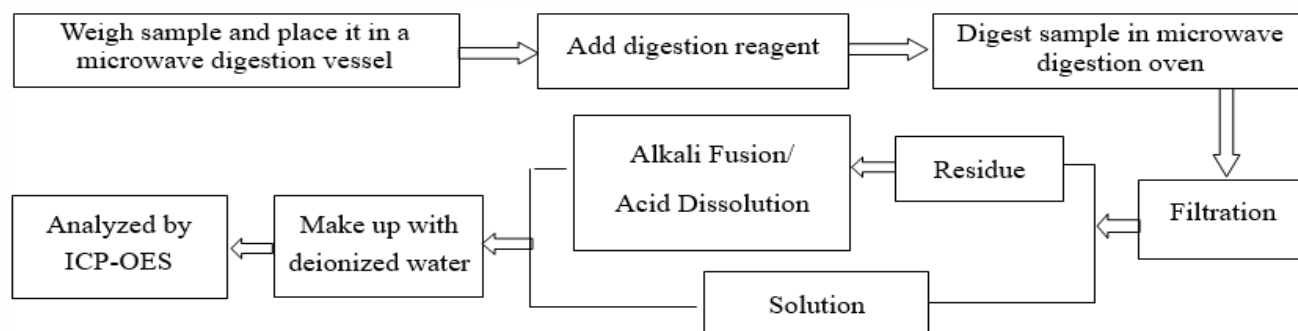

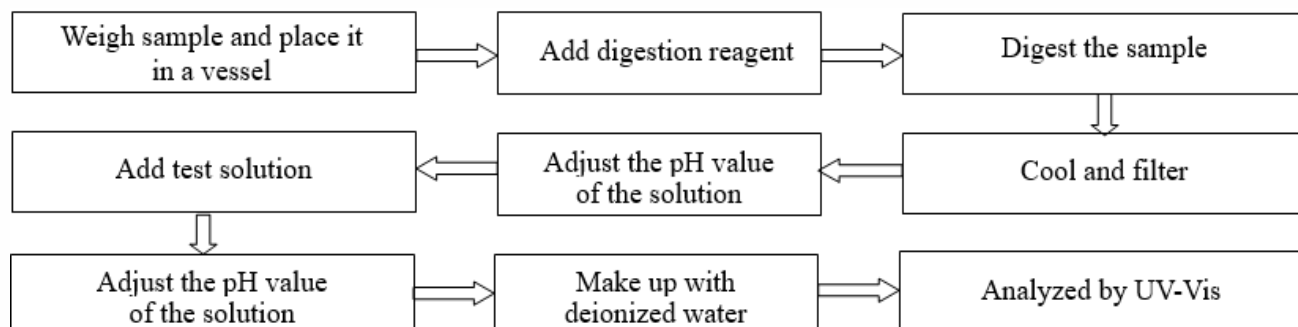
### 1. Lead (Pb), Cadmium (Cd), Chromium (Cr)



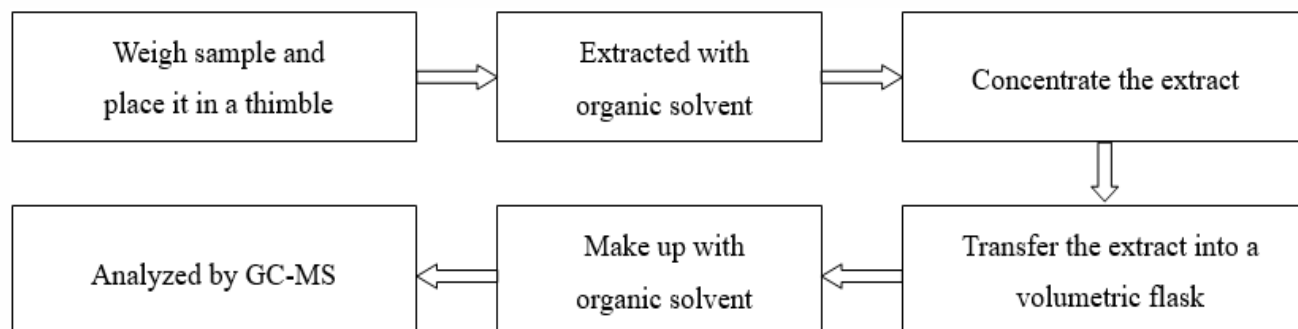
### 2. Mercury (Hg)

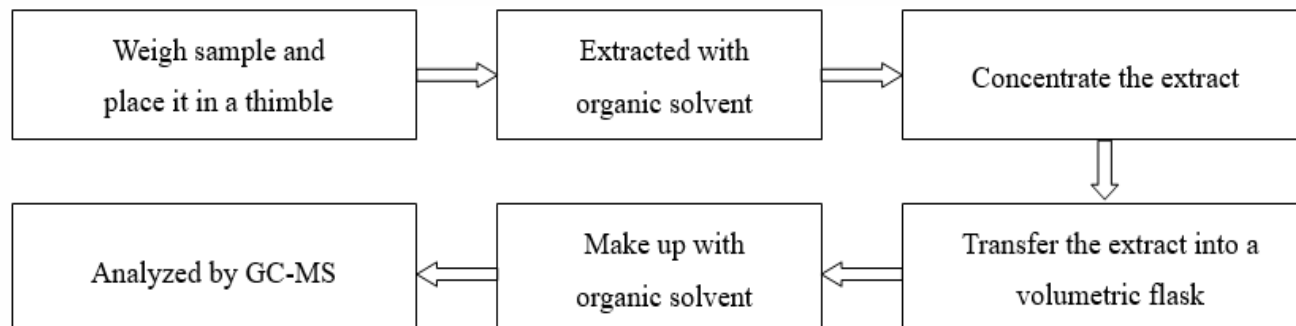

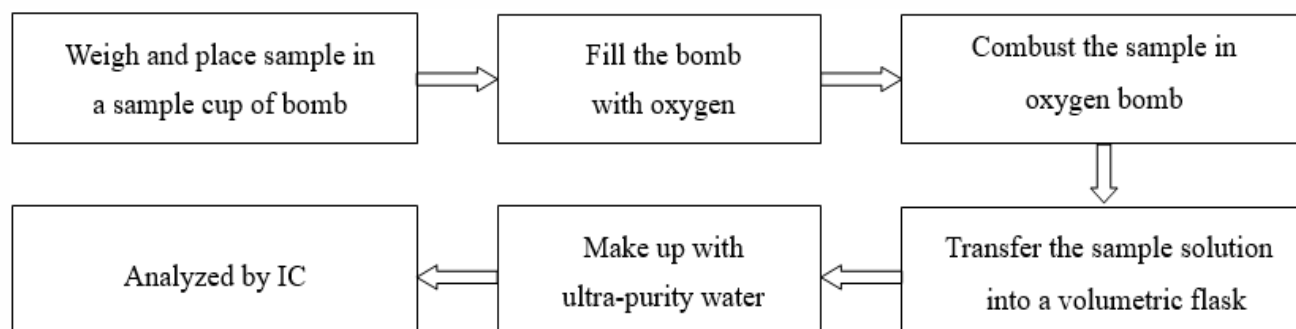

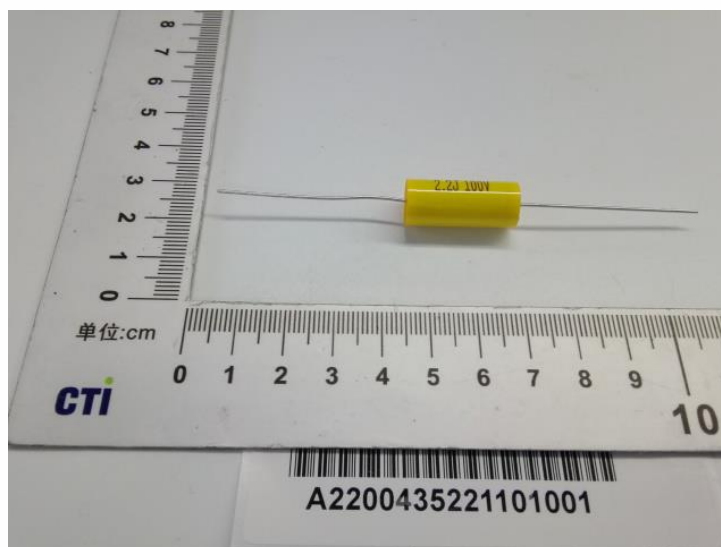
